**Policy, Plan, and Zoning Consistency:** The proposed zoning ordinance amendments are consistent with the City of Davis General Plan, Core Area Specific Plan, Zoning Ordinance, and Downtown and Traditional Residential Neighborhood Design Guidelines.

**Previous Relevant Environmental Analysis:** Previous environmental review was prepared for the General Plan, Core Area Specific Plan and Downtown and Traditional Residential Neighborhood Design Guidelines. The proposed zoning amendments will be consistent with the environmental review previously adopted, but further review of potential impacts is included within this initial study.

## **Description of Project:**

The City of Davis is seeking to amend Article 40.15 of the City of Davis Municipal Code which refers to the Mixed Use (M-U) Zoning District. The purpose of the proposed amendment is to further clarify development standards and to provide consistency between the zoning ordinance and the Davis Downtown and Traditional Neighborhoods Design Guidelines. Proposed amendments include changes to uses, open space, setback, lot coverage, residential use requirements and the creation of an Old North subarea.
